Overview of Pricing:

The final package price for services booked for the contracted event will be determined upon completion of the outline above and below. A non-refundable retainer of 50% of the services agreed upon and booked is due immediately upon execution of this agreement. The remaining balance is due 30 days prior to the contracted event.

Payment may be made by cash, check, money order or credit/debit card. In the event that a check is returned with insufficient funds, Client is responsible for any penalties incurred.

Client and Revive Salon & Spa Studio LLC agree that if payment is made by anyone other than Client, the terms and conditions of this Agreement are in no way waived or otherwise affected, that Client's duties and responsibilities under this Agreement remain exclusively with Client, and that Revive Salon & Spa Studio LLC is answerable only to Client for the contracted services.

Services Performed:

All wedding party participants receiving services agree to be prepped for services reserved. For hair services, individuals booked MUST arrive with clean and dry hair. For makeup services, individuals booked MUST arrive with a clean face. In the event that clients receiving services are not properly prepared, a time conflict issue may arise. Revive Salon & Spa Studio LLC has the right to condense services due to time restraints.

On Location Agreement:

Client agrees and acknowledges that Revive Salon & Spa Studio LLC will require adequate space to perform services. Electrical outlets, tables and chairs must be available to perform services. Revive Salon & Spa Studio LLC agrees to supply all products, hot tools and styling tools including but not limited to bobby pins, hair ties, hair pins, etc. (hair *jewelry* is bridal parties responsibility and is NOT provided).

Model Release:

Client hereby grants Revive Salon & Spa Studio LLC the irrevocable and unrestricted right to use and publish photographs of Client or members of the bridal party taken by the Revive Team for use in editorial, trade, advertising, or any other purpose in any manner.

Postponement or Cancellation Notice:

If the ceremony is postponed due to the incapacitation of the bride, groom or a member of their immediate families, Revive Salon & Spa Studio LLC will make every reasonable effort to reschedule their services to a new date convenient for both parties.

If Revive Salon & Spa Studio LLC is able to accommodate the new date, and is able to fill the time blocked away from the salon for the original date specified, then payment terms above will apply to the new date agreed upon.

If Revive Salon & Spa Studio LLC is previously booked for the new date and therefore unable to provide services on the new date, then Client will forfeit their retainer. Client will also be responsible for forfeiting the remainder balance if the date is cancelled with less than 30 day notification.
